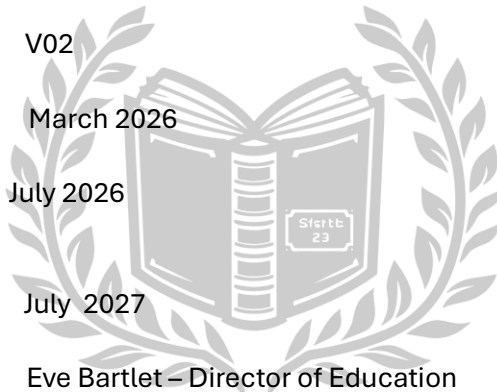


Relationship and Sex Education Policy (RSE)

It is informed by the Department for Education statutory guidance 'Relationships Education, Relationships and Sex Education (RSE) and Health Education' (latest version) and the Independent School Standards Regulations 2014 (ISS), supported by the Independent School Standards Guidance (April 2026 or latest). The school applies this framework alongside Keeping Children Safe in Education (latest) and Working Together to Safeguard Children (latest) to ensure safeguarding, curriculum integrity, and compliance.

Introduction and aims

The purpose of this policy is to ensure that our Relationships and Sex Education (RSE) and Health Education supports our school ethos and fulfils our school aims, which are defined as:

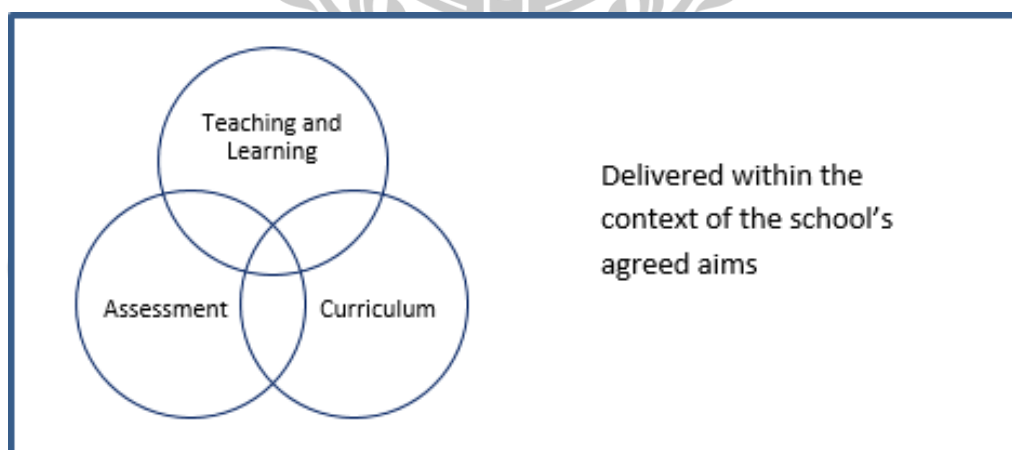
- ✓ to develop the whole individual through high quality learning experiences and opportunities for Character Development.
- ✓ to promote high levels of personal esteem, resilience, confidence and courtesy.
- ✓ to create an environment in which we each respect and value each other's rights, needs and abilities.
- ✓ to prepare pupils for the future, promoting a global perspective

This policy applies to all pupils within our school.

This policy forms part of our curriculum.

We see the curriculum as, 'The total learning experience for our pupils, which includes not only the taught lessons but also the routines, behaviours, events, activities, and other opportunities that our pupils experience on a daily, weekly and yearly basis in order to ensure that all of them make the best progress possible and attain high standards'.

A well-structured and coherent curriculum is a fundamental element of the tripartite education that underpins all successful schools and includes Teaching, Learning and Assessment (see model below) and is underpinned by Wellbeing for Life Model.



The aims of RSE at our school are to:

RSE forms an important part of the school's safeguarding curriculum. Through RSE, pupils are supported to recognise healthy and unhealthy relationships, consent, coercion, exploitation, grooming, online harms, child-on-child abuse and situations where they may need help or protection. Staff recognise that RSE can provide opportunities for pupils to disclose concerns and therefore safeguarding remains central to all delivery.

Professional curiosity is fundamental to effective safeguarding within RSE. Staff will remain alert to verbal and non-verbal indicators of concern, changes in presentation, disclosures, repeated themes within pupil discussions, relationship concerns, online behaviours and signs of vulnerability. Staff will consider whether information shared during RSE may indicate wider safeguarding needs requiring intervention or support.

- Provide a framework in which sensitive discussions can take place.
- To support the School Behaviour Policy and ethos/values.

- Ensure that every pupil is provided with RSE, except for those excused.
- Prepare pupils for puberty and give them an understanding of sexual development and the importance of health and hygiene.
- Help pupils develop feelings of self-respect, confidence and empathy.
- Create a positive culture around sexuality and relationships.
- Teach pupils the correct vocabulary to describe themselves and their bodies.
- Help pupils understand that healthy relationships are an important part of wellbeing.
- Ensure that key issues related to sexualities are not taught in isolation but in part of a broader context.
- To ensure young people stay safe and healthy and manage their academic, personal and social life positively.

Statutory requirements

Our policy follows the latest statutory guidance issued by the Department for Education and meets the requirements of the Independent School Standards Regulations 2014 (ISS), supported by the Independent School Standards Guidance (April 2026 or latest). The school ensures compliance with all relevant legislation including the Children and Social Work Act 2017 and the Relationships Education, Relationships and Sex Education and Health Education (England) Regulations 2019.

Aspects of RSE are infused within the day-to-day operation of our school; incorporated through the curriculum, both in content included in subject schemes of work and through other planned learning opportunities in the school. They are captured in our written aims and expressed in the ethos and behaviours of everyone.

In our School, we must ensure that every registered pupil who is provided with secondary education at the school is provided with relationships and sex education, except in so far as the pupil is excused as mentioned in sub-paragraph 9, in accordance with sections 34 & 35 of Children and Social Work Act 2017 and the Independent School Standards, and with regard to guidance outlined in Section 403 of the Education Act 1996, as issued by the Secretary of State.

As an independent school we must provide Relationships Education to all our pupils as stated in the 'Relationships and Sex Education and Health Education (England) Regulations 2019'. Updates: 1.09.2021

At our school, we teach RSE as set out in this policy.

Policy development

The RSE policy has been developed in consultation with staff. The consultation and policy development process involved the following steps:

- ✓ Review – The Head of School reviewed all relevant information, including but not limited to, relevant national and local guidance.
- ✓ The policy is in accordance with statutory guidance and aligned with the Independent School Regulations.
- ✓ Staff consultation – school staff were given the opportunity to review the policy and make recommendations.

- ✓ Ratification – once amendments were made, the policy was shared with the Director of Education and ratified.
- ✓ Policy review – this policy will be reviewed yearly.

Definition

RSE is about the emotional, social and cultural development of pupils, and involves learning about relationships, sexual health, sexuality, healthy lifestyles, diversity and personal identity.

RSE involves a combination of sharing information and exploring issues and values.

RSE importantly makes the distinction between the physical action of sexual activity and the emotional relationships that comes with it.

RSE is not about the promotion of sexual activity, sexual orientation, or a specific sexual identity.

Curriculum

Our curriculum is set out in Appendix 1, but we may need to adapt this as and when necessary.

We have developed the curriculum in consultation with the staff, taking into account the age, needs and feelings of pupils via MDT's, PEP's, EHCP, questionnaires. If pupils ask questions outside the scope of this policy, teachers will respond in an appropriate manner, so they are fully informed and do not seek answers online.

The RSE and PSHE curriculum compliments the whole school approach to pupil well-being and links to the school's other policies such as Behaviour, Anti Bullying and Safeguarding Policies.

Delivery of RSE

RSE is taught within the PSHE curriculum. The PSHE course is delivered to all pupils through discrete weekly PSHE lessons taught by teachers (see **Appendix 1**). Elements of the program may be supported through the bringing in of additional expertise, such as outside speakers, trained health professionals, or the use of teachers with a particular interest or knowledge in a specific area.

The curriculum content is delivered in a non-judgmental and factual way which allows pupils to ask questions, either as part of a group or through anonymousness such as question boxes.

Relationships Education focuses on teaching the fundamental building blocks and characteristics of positive relationships, helping them to develop healthy, nurturing relationships of all kinds, including:

- Families and people who care for me.
- Respectful relationships, including caring friendships.
- Online and media.
- Being safe
- Intimate and sexual relationships, including sexual health. (Age appropriate or depending on the context of students)

In addition to these discrete sessions, PSHE is also embedded within the curriculum (E.g., social issues through the teaching of English Literature; Health through Biology and PE; Citizenship through History & RE). There are also centrally organised sessions which supplement the delivery

in-house.

Aspects of RSE are also taught within the Science curriculum by education staff.

- describe the role of hormones in human reproduction including the control of the menstrual cycle.
- estrogen, progesterone, FSH and testosterone
- explain the interactions of FSH, LH, estrogen and progesterone in the control of the menstrual cycle.
- explain the use of hormones in contraception and evaluate hormonal and non-hormonal methods of contraception.
- relative effectiveness of the different forms of contraception
- Discussion into the various methods of contraception and their effective/ethical use
- explain the use of hormones in modern reproductive technologies to treat infertility.

Other aspects such as families, different types of relationships and marriage, divorce and IVF treatment are included in R.S.E.

The areas of learning for family are taught within the context of family life, taking care to ensure that there is no stigmatisation of children based on their home circumstances (families can include single parent families, LGBTQ+ parents, families headed by grandparents, adoptive parents, foster parents/carers amongst other structures), along with reflecting sensitively that some children may have a different structure of support around them (for example: looked after children or young carers).

Additional aspects can be covered in assemblies and form/tutor time activities. The religious background of all pupils will be considered, and activities planned accordingly to ensure all content is handled sensitively and appropriately.

For more information about our RSE curriculum, see Appendices 1 and 2.

Roles and responsibilities

Designated Safeguarding Lead Responsibilities: The DSL will maintain strategic oversight of safeguarding issues arising through RSE and ensure that any concerns identified through curriculum delivery are responded to promptly and appropriately. The DSL will ensure that safeguarding, attendance, behaviour, mental health, SEND, Family Help, Child in Need, Child Protection and contextual safeguarding information are considered holistically when assessing concerns.

The DSL will review safeguarding themes emerging from RSE delivery, provide guidance and support to staff, oversee referrals and multi-agency working where required, and ensure that pupils identified as vulnerable receive appropriate support and intervention. The DSL will also ensure that staff understand reporting procedures and safeguarding expectations linked to RSE.

The Director of Education and Executive Head of School

The Director of Education and Executive Head of School will approve the RSE policy and hold the Head of School to account for its implementation.

The Director of Education and Executive Head of School will ensure that:

- All pupils make progress in achieving the expected educational outcomes.
- The subjects are well led, effectively managed and well planned.

- The quality of provision is subject to regular and effective self-evaluation.
- Teaching is delivered in ways that are accessible to all pupils with SEND.
- Clear information is provided for parents/ careers on the subject content and the right to request that their child is withdrawn; and,
- The subjects are resourced, staffed and timetabled in a way that ensures that the school can fulfil its legal obligations.

The Head of School

The Head of School is responsible for ensuring that RSE is taught consistently across the school, and for managing requests to withdraw pupils from [non-statutory/non-science] components of RSE (see “pupil” section).

The Head of School and DSL will work closely together to ensure safeguarding considerations remain embedded throughout curriculum planning, staff training, quality assurance activities and responses to emerging safeguarding risks.

Leadership and Overview

The staff who have the main responsibility for the overview and yearly evaluation of this policy are the Head of School, Executive Regional Head Teacher and Director of Education. However, all staff are responsible for ensuring this policy is implemented and acted on.

When evaluating the use and impact of this policy, the Head of School will evaluate the extent to which there is evidence of a curriculum which:

- Fulfils the aims of the school.
- Embeds aspiration, attributes and the expectation to achieve high standards and high rates of progress; and
- Provides engagement and excitement for learning.

Staff

Staff are responsible for:

Staff should apply professional curiosity throughout RSE delivery. This includes recognising that children may disclose concerns indirectly, may test adult responses before disclosing fully and may communicate concerns through behaviour rather than words. Staff should remain alert to cumulative concerns and seek safeguarding advice where appropriate.

- Delivering RSE in a sensitive way.
- Modelling positive attitudes to RSE.
- Monitoring progress.
- Responding to the needs of individual pupils; and
- Responding appropriately to pupils whose parents/careers wish them to be withdrawn from the [non-statutory/non-science] components of RSE.

Staff do not have the right to opt out of teaching RSE. Staff who have concerns about teaching RSE are encouraged to discuss this with the Head of School.

Staff who will be delivering RSE lessons are trained professionals.

Pupils

Pupils are expected to engage fully in RSE and, when discussing issues related to RSE, treat others with respect and sensitivity.

Pupils with Special Educational Needs and Disabilities

The school recognises that some pupils with SEND may be more vulnerable to exploitation, coercion, manipulation, harmful sexual behaviour, child-on-child abuse, online harm and unhealthy relationships. RSE will therefore include targeted teaching, reinforcement and support to strengthen protective factors and promote safety.

Our curriculum is inclusive and our RSE and Health Education is accessible for all pupils.

High quality teaching that is differentiated and personalised will be the starting point to ensure accessibility for all students.

The school is aware that some pupils are more vulnerable to exploitation, bullying and other issues due to the nature of their SEND. Relationships Education and RSE can also be particularly important subjects for some pupils; for example, those with Social, Emotional and Mental Health needs or learning disabilities. Such factors will be taken into consideration in designing and teaching these subjects.

Parents' right to withdraw

If parents/carers require more information on RSE for secondary aged children, this is a useful information source of information for them:

As of September 2020, The Relationships Education, Relationships and Sex Education, and Health Education (England) Regulations make it clear that pupils receiving secondary education must be taught RSE (Relationships, Sex and Health Education). Under DFE guidance, parents will continue to have a right to request to withdraw their child from sex education delivered as part of RSE in secondary schools. There is no right to withdraw from the elements covered in the National Curriculum e.g. in science. From three terms before a child turns 16 (i.e. in year 10), if the child themselves wishes to receive sex education rather than be withdrawn, the School will make arrangements for this to happen in one of the three terms before the child turns 16; the legal age of sexual consent. There is no right to withdraw from Relationships Education as the contents of these subjects, such as family, friendship, safety (including online safety), are important for all children to be taught.

Parents and carers who wish to withdraw their child should inform the Head of School, in writing, of their decision and will be asked to meet with the Head to discuss their concerns. In such cases the school will endeavour to make alternative arrangements. At all stages, parents and carers are very welcome to meet staff to discuss and view materials which they are concerned about. Requests for withdrawal should be put in writing using the form found in **Appendix 3** of this policy and addressed to the Head of School.

A copy of withdrawal requests will be placed in the pupil's educational record. The Head of School

will discuss the request with parents/ careers and take appropriate action.

Alternative work will be given to pupils who are withdrawn from sex education.

Training

Training will include safeguarding responsibilities, professional curiosity, child-on-child abuse, harmful sexual behaviour, contextual safeguarding, online risks, consent, exploitation indicators and procedures for responding to disclosures arising during RSE lessons. Staff are trained on the delivery of RSE as part of their professional development.

External visitors, such as school nurses or sexual health professionals, might be invited into school to provide support and training to staff teaching RSE and to review the teaching resources.

Monitoring arrangements

Multi-agency working supports the effective delivery of RSE and safeguarding outcomes. The school may work with health professionals, school nurses, Family Help services, Children's Social Care, CAMHS, educational psychologists, police, specialist charities, safeguarding partnerships and other agencies to support curriculum development, pupil wellbeing and safeguarding responses.

Information sharing will be lawful, proportionate and focused on safeguarding and promoting the welfare of children. Effective partnership working, professional challenge and timely information sharing help ensure pupils receive the right support at the right time.

The delivery of RSE is monitored by the Head of School, Executive Head of School, Director of Education through:

- Line Management
- Learning walks
- Observations
- Pupil feedback

The delivery of RSE is monitored by Eve Bartlet through work scrutiny, learning walks, Drop ins, Pupil Voice.

Pupils 'development in RSE is monitored by Head of School and teachers/ instructors as part of our internal assessments systems.

This policy will be reviewed by Head of School and Executive Head Teacher/ Director of Education annually. At every review, the policy will be approved by the Director of Education in liaison and consultation with all stakeholders parents and carers, including resources.

Enhanced Requirements and Expectations

This policy is implemented in a way that actively promotes equality, inclusion and respect for all pupils, in line with the Equality Act 2010 and the school's Equality and Diversity Policy.

Relationships and Sex Education (RSE) is delivered sensitively, recognising protected characteristics and the diversity of family life, background, identity and lived experience.

Staff recognise that RSE learning may prompt disclosures or raise safeguarding concerns. Any such concerns are responded to promptly and appropriately in line with the school's Safeguarding and Child Protection Policy.

RSE contributes to pupils' understanding of healthy, respectful and safe relationships but does not replace safeguarding procedures.

The delivery of RSE is inclusive and accessible for pupils with Special Educational Needs and Disabilities (SEND).

Teaching approaches are adapted to support understanding, emotional safety and meaningful engagement. Pupil voice is actively encouraged and informs curriculum review.

Quality Assurance and Continuous Improvement

The school evaluates the effectiveness of RSE through monitoring, pupil voice, staff feedback and safeguarding review.

Leaders ensure alignment with safeguarding guidance including Keeping Children Safe in Education and Working Together to Safeguard Children.

Professional Curiosity and Safeguarding Oversight: Leaders and staff recognise that RSE may reveal unmet need, abuse, exploitation, harmful sexual behaviour, relationship concerns or wider safeguarding risks. Staff are expected to remain professionally curious, analyse patterns and seek advice when concerns arise. The DSL will review trends and emerging themes to inform curriculum development, staff training and safeguarding priorities.

Governance oversight ensures compliance with statutory duties and continuous improvement in delivery and outcomes.
